

## Prize Draw Rules : Win a Holiday in New Zealand.

01. The promoter is Silver Fern Services Limited (hereinafter "SFS") whose registered office address appears below and who, in respect of these Prize Draw rules, may be communicated with in writing at PO Box 1194, SANDHURST, Berkshire GU47 7DA, or, by facsimile, to the number appearing in the "Contact Us" page of this website.
02. Entry to the SFS "Win a Holiday in New Zealand" prize draw competition is free, no purchase being required.
03. Participation may only be effected by accurately, and comprehensively completing the online entry form available at "Contact us online", on the SFS website, at domain ; [www.silverfernservices.com](http://www.silverfernservices.com) and prior to the 31st of December 2016 sending the completed entry form by e-mail to [sales@silverfernservices.com](mailto:sales@silverfernservices.com).
04. Entries will be acknowledged by e-mail, but, only where entrants elect to receive a copy by e-mail of the entry form which they complete.
05. Each entrant, by entering, accepts these SFS "Win a Holiday in New Zealand" prize draw competition rules and further confirms their willingness to receive promotional communications, including telephone calls from time to time, from SFS and / or its affiliates.
06. Entry is restricted to persons aged 18 years or older, who at the time of entry were (and can prove themselves to have been if required by the Promoter and to the Promoter's satisfaction) resident in the United Kingdom, and in full time employment with a business or charity which is commonly recognised as promoting nationally on a substantial (in advertising expenditure terms) scale to consumers in the United Kingdom, (or, might reasonably be perceived as wishing to promote nationally on such a scale to such consumers) or, who is in full time employment in an advertising or sales promotion agency which works on United Kingdom promotions for such an organisation. Hereinafter the aforementioned business, charity, or, advertising or, sales promotion agency shall be referred to as "Employer".

Entry is also restricted such that no more than 5 individuals per Employer may be entered and such individuals must be actively, regularly and continuously employed in roles directly encompassing responsibilities for advertising, sales promotion, brand management, direct marketing or similar on behalf of such Employer.

Entry is further restricted such that it precludes employee's and officers of SFS, and family, friends and associates of same and such people whose Employer is an affiliate of SFS and further, precludes persons connected with arranging for, or, enacting, the draw.

07. SFS advise all intending participants in its "Win a Holiday in New Zealand" prize draw not to breach any terms of their contract of employment by entering. Prior to SFS issuing any prize entitlement notice, the name and other details of each winning entrant will be notified to the Employer who employed the winning entrant at the time of entry, and such Employer will have the right to have the prize awarded to a person other than the entrant. With the permission of such Employer SFS will allocate and award the prize to any winner provided that ;
  - (i) The winner agrees that SFS shall be entitled to use his/her name and photography taken by SFS in reasonable manner, without restriction, in such future publicity for SFS as SFS wish.
  - (ii) The Employer agrees that SFS shall be entitled to use his/her name and corporate logo and / or brand images in reasonable manner, without restriction, in such future publicity for SFS as SFS wish.
  - (iii) SFS shall be entitled at its sole discretion to determine the dates and times of flights, accommodation and excursions constituting any prize awarded.
  - (iv) SFS shall be entitled at its sole discretion to determine the parties who will provide air travel, accommodation and excursions constituting any prize awarded.
  - (v) The winner must himself / herself be one of the persons who travels to New Zealand. The prize is not transferable and no cash alternative will be offered.
09. Each of up to two entrants could win a prize consisting of ;
  - Return airfares to New Zealand for 4 people
  - Premier hotel accommodation whilst in New Zealand
  - All accommodation, paid for whilst in New Zealand
  - Internal flights within New Zealand paid for
  - £2,000 spending money
  - Five pre-paid excursions of choice such as Big Game fishing in the Hauraki Gulf, skiing powder slopes on Mt. Cook, a helicopter flight over lakes and glaciers, or, whale watching near Kaikoura.

10. SFS reserve the right without notice to alter one or more component elements of the prize.

Following the 31st of December 2016, the first prize draw Close Date will be altered on the SFS website, at domain ; [www.silverfernservices.com](http://www.silverfernservices.com) and thereafter the Close Date displayed will be the second prize draw Close Date. Entries received by the 31st of December 2016 (the first draw Close Date) will entitle the entrant to a participatory entry in a draw for each of the two holiday prizes. All entries for either draw must have been received by SFS, in the prescribed manner by e-mail, prior to their respective Close Date.
